**POLICIES**

**ENROLLMENT...** We require students to be enrolled for at least 8 lessons. We feel that this is the minimum amount of time needed for students to adapt to our program and begin making significant progress.

**TUITION: ...** The full or pro-rated tuition and a completed enrollment packet for the current month is due at the first lesson. Tuition can be made by cash, check or credit card, but we must have a credit card on file for every student. Tuition is due on the 20<sup>th</sup> of the month for the following month. If we have not received tuition by the 25<sup>th</sup> of the month, the credit card on file will be automatically charged. Monthly tuition can also be charged or debited automatically for you on the first of the month, by submitting the completed authorization form found in your enrollment packet. Any returned checks or declined credit cards will be assessed a \$25 late fee.

**WITHDRAWAL POLICY...** We require a 30 day advance notice to withdraw from classes. Withdrawal forms are available at the front desk. If we have not received a withdrawal form, and tuition has not been received by the 25<sup>th</sup> of the month, the credit card on file will be charged.

**REFUNDS...**We do not honor any refunds.

**MAKE-UPS...** Please make every attempt to attend your child’s regular scheduled swim lesson. We do not guarantee make-up lessons, however, we make every attempt to honor them because we do not want to interrupt your child’s learning and progress. In order to be eligible for a make-up, you must call and cancel **before** you miss your class. If we do not receive **advanced notice** that you will be missing a lesson, you **will not** be eligible for a make-up. Students who are eligible for a make-up, have 14 days to complete their make-up. To schedule a make-up, you must call our office in the morning to see if we have a make-up lesson available for that day. If we do not have one available, you must try and call again on another day within the 14 days. If you do not attend...or cancel a scheduled make up class, it becomes forfeited. Any missed lessons that are not able to be made up within 14 days, may be scheduled for a Saturday family free swim.

**SUBSTITUTE TEACHERS...** In the instance that your child’s instructor may need to miss a lesson, a substitute instructor will be provided.

**SWIM DIAPERS...** It is imperative that we maintain a healthy and clean pool for all our students. ALL children ages, three and under must wear a health approved re-usable and washable swim diaper with snug-fitting elastic around the legs and waist before entering the pool. If your child has a fecal accident in the pool and is not wearing an approved diaper, a \$100 fine will be charged to the credit card on file.

**POOL ENTRY...**In order to protect our learning environment, children are not permitted to enter the water or sit on the edge of the pool until their scheduled lesson time and must stay seated with a parent at all times.

**SHOWERS...**All students are required to shower before entering the pool and after their lesson.

**SAFE CHILDREN...**For the safety of all children, absolutely no changing is permitted on the pool deck or in the showers.

**PARENT SUPERVISION...** Parents are responsible for the safety and supervision of their children at all times. Children must stay clear of the pool except during their lesson time. Parents must remain inside the facility during their child’s swim lessons. No children are permitted to play with the teaching tools on deck at any time. Teaching tools need to be accessible to our instructors at all times and are not to be played with.

**PARENT SUPPORT...**We welcome and encourage cheers for your child during his/her lesson time! However, please refrain from adding your own input or correction, as this can be confusing to your child and distracting to their instructor.

**MEDICAL RELEASE...** If your child has any medical conditions or is under the care of a physician, previously or while attending swim lessons with Swim to Shore, a Doctor’s Release must be provided permitting your child to participate.

**HOLIDAYS...** Monthly membership fees are based on a four-week month, which means that, depending on the calendar, you may receive an extra week, which will compensate for the school being closed on Holidays. We observe the following Holidays: President’s Day, Memorial Day, 4<sup>th</sup> of July, Labor Day, and Thanksgiving weekend. (Thursday, Friday and Saturday) December fees will be pro-rated and based on only three weeks of lessons. (We will be closed December 22-Jan. 2nd).

**POOL CLOSURE...** If classes are cancelled for circumstances beyond our control, we will provide a make-up lesson or an extended “free swim” time for our students.
